

**TOWN OF LISMAN
RESOLUTION 2025-16**

**RESOLUTION ADOPTING TRANSPORTATION PLAN PURSUANT TO THE
REBUILD ALABAMA ACT**

WHEREAS, the Alabama legislature in Act. No. 2019-2 adopted the Rebuild Alabama Act; and

WHEREAS, the Rebuild Alabama Act provides for an allocation among the municipalities of the state on the basis of the ratio of population of each municipality to the total population of all municipalities of the state a portion of the additional taxes levied under the Act to be used for transportation infrastructure, improvement, preservation and maintenance; and

WHEREAS, the Act provides that the municipal governing body of the Town of Lisman shall adopt an annual Transportation Plan no later than August 31, 2025 which shall provide a detailed list of projects for which expenditures are intended to be made in the next fiscal year and shall be based upon an estimate of the revenues anticipated from the fund in which the additional revenue is deposited during the next fiscal year; and

WHEREAS, the Act further provides that any such funds shall be used only for the maintenance, improvement, replacement, and construction of roads and bridges maintained by the Town of Lisman and such other uses as are defined in the Act; and


WHEREAS, the Town Council of Lisman, Alabama is desirous of utilizing the funds allocated for the 2020-2024 years, for patching and paving, and save 2025 funds for future projects.

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Lisman as follows:

1. The Town Council of the Town of Lisman hereby passes this Resolution as its Transportation Plan submitted in compliance with the Rebuild Alabama Act No. 2019-2.
2. Pursuant to the Act, the Town Council of the Town of Lisman estimates that its anticipated allocation from the Rebuild Alabama Act fund for the next fiscal year will be approximately \$20,714.19, with increasing allocations for each fiscal year thereafter.
3. Pursuant to the Act, the Town anticipates expending funds received pursuant to the Act, in part or in whole, to fund any of the following listed projects: Maintenance and improvement of streets and roads, including Re-paving portions of West 3rd Avenue, West 2nd Avenue, Coleman Circle, Howard Avenue, Kinnon Circle, and Church Court.


4. The Town Clerk is hereby authorized and instructed to post a copy of this Resolution as its Transportation Plan in a conspicuous place at the Town Municipal Hall, and also on the website of the Town of Lisman.






